Cancellation/Withdrawal Policy:

- Seventh Chakra Yoga and its principals reserve the right to remove any trainee who is deemed disruptive or uncommitted to the teacher training process, anytime during the course. Their participation in the training will be deemed cancelled on the day and written notice is sent to them by Priya Jain, Studio Owner and Course Director.
- All cancellations and/or withdrawals must be made in writing, and be dated, received by and/or sent by Priya Jain, Studio Owner and Course Director
- Withdrawals /cancellations prior to the first day of the course will be eligible for a refund less \$350 administration fee.

- For withdrawals after the start of the course, please review the refund cancellation policy schedule below for attendees who have paid in full:

- o After January 15th \$ 1,120
- o After February 15th \$ 680

- There will be no refunds given for withdrawal after the 2nd month of the course.

- **Students on a payment plan** are not eligible for any refund once the course has begun. The student will be responsible to complete any payments owed. Payment plan will be cancelled onwards, from the date the withdrawal is approved by the administrator.

- All paid fees may be applied within 2 years to future Level 1 Teacher Training courses with payment of an additional \$400 administrative fee.

- **Course Certification:**

- Attendance is one of the key requirements for certification. If more than two weekends, or the equivalent of four days of course class time is missed, then the student will not be eligible for certification. If less than four days of class time is missed, then the appropriate make-up work must be completed to be eligible for certification.
- All paid fees and requirements completed may be applied within 2 years to future Teacher Training courses at Seventh Chakra Yoga only, with an additional \$400 re-activation fee. After the 2 year grace period the student is required to begin the course again in order to pursue certification.
