Cancellation/Withdrawal Policy:**Evaluation for Suitability:**

Each prospective student applying to study at the Seventh Chakra Institute of Spiritual Sciences, will be evaluated on his or her own readiness for the program, based on his/her intake form and an interview with Seventh Chakra Institute's Lead Trainer and/or Training team. The Lead Trainer will determine the fitness of each candidate for the program. The acceptance of the registration fee does not confirm attendance in the program. If the Lead trainers deem that this training program is not suitable for the student or the Institute is not a good fit for the applicant, the registration fee will be fully refunded and every attempt will be made to assist the applicant in finding a suitable alternative program or support.

Admission Denials

An applicant who is denied admission into the program is entitled to a full refund of all money paid by said applicant.

Notice of Cancellation

The program requires that any notice of cancellation or withdrawal by a student must be provided via email to

Communication to Group Teaching Assistants or casual conversation with Institute Administrators does not constitute notice or intent of withdrawal from the program.

Cancellations After Three (3) Days But Before Program Start Date

An applicant who submits written notice of withdrawal from the program more than three (3) business days after signing the training agreement, but before the program begins, is entitled to a refund of all money paid less the \$350 administration fee. The refund will be paid within thirty (30) days of receiving the notice of cancellation.

Cancellations Within the First Week of Training

For an applicant requesting cancellation within the first week of training, refund will reflect deduction for the cost of learning materials, \$350 administrative fee and prorated amount for training sessions and retreat expense. Any pre-scheduled payments will be cancelled at that point. The refund will be paid within thirty (30) days of receiving the notice of cancellation.

Refunds After the First Week of Training

There will be no refunds after the start date of the program. If the applicant withdraws from the program for any reason after it starts, the applicant will be responsible for paying the full tuition, regardless of any partial payments that have been made to date.

Special Situations

In case a student needs to withdraw from the program due to illness, accident, death in the family, or other circumstances that make it impractical for the student to complete the course, the program will provide a reasonable and fair refund.

Termination from Program:

No refunds will be given if a student is removed or terminated from the program.

The program may decide to terminate any student's participation in the program if: (1) false information was used in the admission process that materially affects the program; (2) a student missed more than 2 weekends of the Training Course without contacting the program director; (3) the student fails to make timely payments of tuition; (4) the student is non-committed to the teacher training process (6) Disruptive or Disrespectful Conduct*

*** Termination from Program for Disrespectful Conduct:**

Disrespectful conduct includes, but is not limited to: rumor mongering about other students or teachers, harassment, bullying, inappropriate sexual behavior, behavior arising from untreated mental illness, threatening or making others feel physically unsafe, any other behavior that is inappropriate or disruptive to the welfare of the program, to fellow students, group TA's, course administrators or Trainers.

If the program decides to end the student's participation in the program, the student is not entitled to any prior payments or fees. All prior payments and fees are non-refundable and non-transferable.

Course Certification:

The Kundalini Research Institute (KRI) and the KRI Teacher Training team at Seventh Chakra Yoga reserve the right to grant KRI Level One certification based solely on their discretion and evaluation of each student's readiness to be a Kundalini Yoga instructor at the end of the course.

Attendance is one of the key requirements for certification. If more than two weekends, or the equivalent of four days of course class time is missed, then the student will not be eligible for certification. If less than four days of class time is missed, then the appropriate make-up work must be completed to be eligible for

certification.

All paid fees and requirements completed may be applied within 2 years to future Teacher Training courses at Seventh Chakra Yoga only, with an additional \$400 re-activation fee. After the 2-year grace period the student is required to begin the course again in order to pursue certification.
